Lifesaving Rules (Railway)

RSP has implemented a set of "Lifesaving Rules" in line with Network Rail's initiative. These rules apply regardless of whatever work is undertaken within the rail sector or not.

Ten Lifesaving Rules to get Everyone Home Safe Every Day:

Working Responsibly

- Always be sure the required plans and permits are in place before you start a job or go on or near the line.
- Always use equipment that is fit for its intended purpose.
- Never undertake any job unless you have been trained and assessed as competent.
- Never work or drive while under the influence of drugs or alcohol.

Working with Electricity

- Always test before applying earths or straps.
- Never assume equipment is isolated always test before touch.

Driving

- Never use a hand-held or hands-free phone, or program any other mobile device, while driving.
- Always obey the speed limit and wear a seat belt.

Working at Height

• Always use a safety harness when working at height unless other protection is in place.

Working with Moving Equipment

• Never enter the agreed exclusion zone, unless directed by the person in charge.

The RSP Management Team are responsible for reviewing this policy on an annual basis. The policy will also be reviewed following any major organisational changes, if an incident/event occurs, or if a report is received that impacts upon the company's Business Operating System (BOS).
